## 101 THE FOX'S "THE GINGERBREAD" CONTEST OFFICIAL RULES

The Station will conduct the **101 The Fox's "The Gingerbread"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age twenty-one (21) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 15 days or a prize valued at \$500 or more in the last 15 days, and whose immediate family members or household members have not won a prize from the Station in the last 15 days or a prize valued at \$500 or more in the last 15 days. - 2. **Contest Period.** The Contest entry period will begin at **6:00am CT on November 29, 2024** and will **run** through **11:59pm CT on December 4, 2024** (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. How to Enter and Win: Send a text message with the keyword GINGERBREAD spelled correctly to 913-600-1011 during the Contest Period. All entries must be received by 11:59pm CT on December 4, 2024 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider
- 4. Winner Selection. On or about 9:00am CT on December 5, 2024, Station will select one (1) potential Prize Winner in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within two (2) days of notification or failure to claim the prize within two (2) days of verification as a winner will result in disqualification and forfeiture of the prize.

A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize.
